

Are you a self-employed AUSTSWIM Licenced Teacher working as a contractor, a SAL Swim Coach, AUSTSWIM WETS Instructor then read on:

- ✓ If you are working as a contractor and working more than 30 hours per week or earning more than \$30,000 p.a then the automatic insurance under your AUSTSWIM Teacher Licence will not provide you with cover, so you will need to arrange your own cover
- ✓ Similarly, if you are hiring lanes in a council pool, or teaching in private pools and have your own clients who pay you directly then you are required to arrange your own cover
- ✓ We have a specic scheme for which we have negotiated reduced rates according to the number of hours per week that you work
- ✓ The standard level of cover we offer is \$10 Million for Public Liability and \$5 Million Professional Indemnity

Property Covers

Building & Contents - Fire

Business Interruption

Business Interruption insurance covers the loss of income that your business suffers as a result of a disaster. If the event is covered by your Building and Contents Insurance EG. fire or storm damage and your swim school cannot operate as a result of the premises being closed for repairs or rebuilding, income lost will be covered.

Breakage of Glass

It is now common practice for lessors of premises to include a clause in the lease stating it is the responsibility of the lessee to arrange insurance cover for glass breakage. We can assist with this cover including any signwriting or signs. Check with your landlord, you may need to insure glass when you pick up the keys.

Burglary

Theft of contents, following a break-in. Things such as computers, stock, heaters and pumps.

Some other insurance for your consideration

Theft of Money

If your swim school receives payments by cash this policy will provide cover for the theft or loss of money while in transit anywhere in Australia or on the premises during business hours and outside business hours.

Machinery Breakdown

Machinery Breakdown Insurance provides cover for repair costs or replacement of fixed machinery such as filtration systems and pool pumps due to mechanical breakdown.
