## Medical Malpractice - Choose your level of protection

This section of the policy provides insurance for all amounts the insured person becomes liable to pay, subject to the sum insured limits of the policy, for claims arising out of the provision of health care services which causes injury to a patient caused by a negligent act, error or omission.

- This section includes one reinstatement of protection.
- It also covers the cost of investigation and defence of any claim up to the limit of this section of the policy.

## Public Liability - \$10 Million insurance protection

This section of the policy provides insurance for all amounts the insured person becomes liable to pay to a third party subject to the policy sum insured limit, for personal injury, loss or damage to property as a result of an occurrence happening in connection with the Doula's business.

- This section of the policy also covers the cost of investigation of any claim up to the limit of this section of the policy.

## Additional Insurance Protection

Insurance is provided for Breach of Confidentiality, Defamation, Libel, Slander, Infringement of Intellectual Property, Breach of the Trade Practices Act, Loss of Documents, Attendance at Enquiries up to the limit of this section of the policy.

## Do You Realise

You don't have to have done something wrong for someone to take legal action against you. If they claim you have been negligent in some way that has caused them financial loss then you can be faced with significant legal expenses defending yourself.

If the nature of their claim falls within the scope of this policy then up to the policy limit your legal expenses will be insured.
